Consequent upon the notification of J&K Civil Services (Revised Pay) Rule, 2009 vide SRO-93 Dated; 15th April 2009, doubt has been expressed by certain quarters regarding exercise of option by a Government employee at the time of regularization of promotion in the post carrying higher pay Band/Grade Pay to which he was promoted earlier in OPG. The issue has been examined in Finance Department, accordingly, clarification as detailed here under is issued for guidance and reference:-

S.No	Doubt	Clarification
1	Whether deferment of fixation of pay on regularization of promotion till next date of increment in terms of Rule 13(a) of J&K civil Service (Revised Pay) Rules, 2009, promulgated vide SRO-93 Dated; 15/4/2009, shall be allowed to such employees who have been promoted in OPG and regularized retrospectively from the same date or a date later thereafter.	It is clarified that whenever a promotion on OPG is followed by regularization retrospectively from the same date or a date later thereafter, the incumbent would have the right to option which is presently available and such cases would continue to be governed by the existing provisions relating to deferment of pay fixation.
