With reference to above noted subject, the Government hereby notifies 126 instalments of COLA (16 instalments from 01.01.2006, 18 instalments from 01.01.2007, 26 instalments from 01.01.2008 and 35 instalments from 01.01.2010 to 30.04.2010 respectively) to those employees of State owned PSUs whose pay scales have not been revised thus far for some reasons and those who have opted to retain existing pay scales even beyond 1.1.2006.
