Subject: - Payment of Dearness Allowance to State Government Employees-
Revised rate effective from 01.01.2010

Reference: - Cabinet Decision No. 137/10/2010 Dated 24.5.2010

**Government Order No. 177/F of 2010
Dated 26/5/2010**

In continuation of Government Order No.10-F of 2010 Dated 8.1.2010, it is hereby ordered that all the Government servants including Work Charged and Whole Time Contingent Paid employees working in regular pay bands /scale shall be paid Dearness Allowance as under:-

Existing Rate of DA	Revised Rate of DA	Date from which applicable
27 %	35 %	01.01.2010

1. The differential amount payable on account of revised Dearness Allowance w.e.f 01.01.2010 to 30.6.2010 to the State Government employees shall be credited to their individual GPF Accounts;
2. The DA arrears w.e.f January 2010 to 30th June 2010 in favour of State Government employees covered under New Pension Scheme and those retiring within next six months shall be paid in cash;
3. The basic pay for the purpose of this order shall mean the basic pay as defined in Note below Article 27(aa) of J&K Civil Service Regulations.
4. The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
5. The provisions of this order shall also apply, *mutatis-mutandis*, in the case of All India Service Officers serving in connection with affairs of the State except retired AIS Officers who shall also be paid arrears in cash..
