**Subject: - Payment of Dearness Allowance to State Pensioners/Family Pensioners-Revised rate effective from 01.07.2009.**

**Government Order No. 11 /F of 2009  
Dated 08-07-2010**

In continuation of Government Order No.188- F of 2009 Dated 31.8.2009, it is hereby ordered that the State Government Pensioners / Family Pensioners shall be allowed Dearness Allowance on pension/ family pension as under:-

Existing Rate of DA	Revised Rate of DA	Date from which applicable
22 %	27 %	01.07.2009

- 2 The Dearness Allowance differential on account of enhancement for the period 1.7.2009 to 31.3.2010 shall be paid to the State pensioners/family pensioners in cash in two equal instalments one each in the month of April and June,2010 respectively.
- 3 The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
- 4 Other provisions governing grant of Dearness Allowance on pension/family pension such as regulation of Dearness Allowance during employment / re-employment, where more than one pension is drawn etc. and other provisions of the existing rules/orders (as are not in conflict to the provisions of this order) shall continue to remain in force.


