Sanction is hereby accorded to the advance drawl of an amount of Rs. 61,43,78,800/- (Rupees Sixty one crore forty three lakh seventy eight thousand eight hundred only) as 1<sup>st</sup> instalment of the premium (i.e. 20% of Rs. 8776.84/- per employee per annum which becomes Rs. 1755.36/- including GST) for 3.50 lac employees towards Group Mediclaim Insurance Policy under Major Head 8235-General & Other Reserve Funds, Sub Major Head:00, Minor Head: 105 General Insurance Fund (Health Insurance), Group Head:00, Sub Head:00 by the Joint Director Resources, Finance Department for subsequent release of the amount to the M/S Reliance General Insurance Company Ltd.

However, 2<sup>nd</sup> instalment of premium of 1<sup>st</sup> year policy shall not be released until the Reliance General Insurance Company ltd shall furnish up to date list of the employees who have been enrolled and provided the Health Insurance Cards. The excess premium amount paid, if any, to the concerned Insurance Company shall be adjusted at the time of payment of 2<sup>nd</sup> instalment.
