**Subject:- Payment of Dearness Allowance to State Government employees continuing to draw their pay as per 6<sup>th</sup> CPC- revised rates effective from 01.01.2018 & 01-07-2018.**

**Government Order No. 408-F of 2018  
Dated 24 - 09 - 2018**

In continuation to Government Order No. 24-F of 2018 dated 25-01-2018, it is hereby ordered that the State Government employees including Work Charged and Whole Time Contingent Paid employees, continuing to draw their pay as per 6<sup>th</sup> CPC, shall be paid Dearness Allowance as under:-

S.No.	Existing Rate of DA	Revised Rate of DA per month	W.e.f.
i.	139% of Basic Pay	142% of Basic Pay	01.01.2018
		148% of Basic Pay	01.07.2018

- a. The arrears on account of the additional instalments from January, 2018 to September, 2018 shall be paid through GPF route and shall form part of the monthly salary from October, 2018 onwards.
- b. The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.


