

Regarding fresh cases, out of seventeen (17), nine (9) have been found eligible, three (3) cases were found deficient and five (5) cases have been found ineligible as these cases have not completed 7 years of service. It was decided that these cases shall be returned to the concerned departments with the advice that they shall resubmit their cases complete in all respects as and when they complete 7 years of service. Abstract details are given in **Annexure "A"** to these minutes.

As far as review cases are concerned, almost in all these cases the concerned departments have furnished the deficient documents and out of one hundred and forty seven (147) one hundred and forty four (144) have been found eligible and three (03) cases have time and again been found deficient. Complete details of cases placed before the EC for scrutiny, verification and review is shown in **Annexure "B"** to these minutes.
