CIRCULAR

In order to ensure transparency and accountability in transaction of Government business, a number of IT enabled initiatives such as JKPaySys, BEAMS, PFMS and DBT have been implemented which has helped in streamlining payment systems.

It is enjoined upon all the Controlling officers/DDOs that all the government transactions shall be made through electronic mode without involving any cash transactions in the Government offices or other offices which are directly or indirectly controlled by the Government, excepting for very small denominations.

A number of autonomous bodies/PSUs operate through bank accounts. It is imperative that digital payments are fully implemented in these bodies as well. It is therefore impressed upon all concerned in such bodies to adhere to digital/DBT payment mode except for very small denominations.

Deviation, if any, to above circular instructions shall be viewed adversely.
