Subject: Procurement of Goods/Services through Government e-Marketplace (GeM).

## Circular

Rule 149 of GFR-2017 provides that it is mandatory for Government departments to purchase Goods and Services through GeM only. Accordingly, all the Administrative Secretaries have been advised to direct their subordinate officers to generate GeM Availability Report and Past Transaction Summary (GeMAR&PTS) for Procurement outside GeM.

There are 2027 registered buyers on GeM in UT of J&K of which 1530 are active and 497 are inactive. Moreover there are 3063 registered secondary buyers and all are active.

However, it has been observed that 24% payments regarding purchases made on GeM are pending till date. As per GeM rules online payments shall be made within 10 days of the issue of consignee receipt-cum acceptance certificate. In majority of the cases although the payments have been released off-line, the same have not been updated on the GeM portal.

Accordingly, all Administrative Secretaries are advised to direct their subordinate officers to make timely payments while making purchases on GeM and update the payments made off-line on the GeM portal regularly.
