Whereas, cases have been received in Finance Department with regard to relaxing of 30% restriction on expenditure during the last quarter of 2021-22 imposed vide Government Order No.321-F of 2021 dated:06.12.2021.

The issue has been examined in the Finance Department and accordingly, authorization is conveyed to the relaxation of 30% expenditure restriction during last quarter of current financial year, in respect of CSS, PMDP, SDRF, NABARD or other loan funding schemes, beneficiary oriented schemes (i.e. Stipend & Scholarship, Honorarium & Renumeration, Compensation, Subsidy etc.), Drugs & Instruments, Pension, Salary, Wages, Grant-in-Aid (Revenue Component), Diet Expenses and funds involving contra-credit which accrues as revenues to the Government, in respect of all the Departments.

This issues with the approval of the Hon'ble Lieutenant Governor.
