Sanction is hereby accorded to the temporary appointment of Mrs. Meenakshi Sharma W/o Late Balbir Kishore Sudan (Ex-Data Entry Operator) R/o Village Siot, P/O Siot Tehsil Siot, District Rajouri, as **Sub-Inspector, in the Pay Scale of Rs. 5200-20200 with the Grade Pay of Rs. 2400/- in the Excise Department, Jammu**, in relaxation of Rule-3 under SRO-43 of 1994.

The compassionate appointment of Mrs. Meenakshi Sharma shall be subject to fulfillment of the following conditions:-

- a) The appointee shall report for duties to the Excise Commissioner, Excise Department within a period of 21 days from the date of issuance of this order.
- b) In case of failure of appointee to join within the stipulated period, her appointment shall be deemed to have been cancelled without any further notice.
- c) The appointee shall be allowed to join only on production of the following certificates in original:-
 - i. Qualification Certificate.
 - ii. Age and Health Certificate.
 - iii. Permanent Resident Certificate.
 - iv. Dependent Certificate issued by the Assistant Commissioner Revenue.
 - v. All other relevant documents as are required under SRO-43/1994.
 - vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
 - vii. Relevant category certificate, if any.

- d) The appointee shall be initially on probation for a period of 02 years and shall undergo and qualify the departmental examination (Excise and Taxation part-I Exam) .
- e) The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim her appointment as Sub-Inspector and her appointment, as such shall be deemed to have been cancelled ab-initio.
- f) If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- g) The salary of the appointee shall not be drawn and disbursed to the appointee unless the satisfactory reports in respect of (e) and (f) above are received in her favour.
- h) The appointment of the said candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
