As recommended by the Department of Disaster Management, Relief, Rehabilitation & Reconstruction, sanction is hereby accorded to the temporary appointment of Shri Sanjay Hangloo S/O Shri Makhan Lal Hangloo R/O Koil Pulwama as EDP Supervisor in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4200/- in Divisional Cadre Kashmir in the Excise Department under Prime Minister's Special Package for Return and Rehabilitation of Kashmiri Migrants in Kashmir Valley.

The appointee shall be allowed to join only on production/ checking/verification of the following certificates in original:-

a) Academic Qualification Certificate.

b) Matriculation / Date of Birth Certificate.

c) Health Certificate issued by Chief Medical Officer.

d) Permanent Resident Certificate issued by the Competent Authority.

- e) Certificate from the concerned authorities to the effect that no loan under self employment scheme has been taken by the appointee concerned.
- f) Certificate of belonging to the reserved category, wherever applicable.

The appointment of the above candidate shall further be subject to the following conditions that:-

- The appointee shall execute an agreement in the "form" prescribed under Jammu and Kashmir, Kashmiri Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30-12-2009
- 2. The appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his character and antecedents is received from Inspector General of Police, (CID) to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his appointment as EDP Supervisor and his appointment as such shall be deemed to have been cancelled ab-initio.
- 3. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- 4. The salary of the appointee shall not be drawn and disbursed to him until and unless satisfactory report in respect of (1) (2) and (3) above are received in his favour.
- 5. The appointees shall be on probation for a period of 02 years.
- 6. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.
- 7. The inter-se-seniority shall be in the order in which his name appear in the Government Order which is according to select list furnished by the Service Selection Board through Department of Disaster Management, Relief, and Rehabilitation & Reconstruction.

The above appointee shall report to the Commissioner, Excise Department, J&K Srinagar within a period of 21 days from the date of issuance of the order for his further posting. In case the appointee does not join within the said period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
