## Government Order No. 228 - FD of 2017 Dated: 24 -07-2017

Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11-08-2015 referred 03 posts of Driver (Divisional Cadre Kashmir) of the J&K Excise and Commercial Taxes(Subordinate) Service to J&K Services Selection Board for selection of suitable candidates under Fast Track Recruitment; and

- 2. Whereas, the Jammu & Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/2017/1197-1204 dated 24.01.2017 forwarded a select list of two candidates for the post of Driver (Divisional Cadre Kashmir) advertised vide item No. 215 and Notice No. 05 of 2015 indicating therein that 01 post of Driver under SC category remained unfilled due to non-availability of eligible candidate under the said category. The Service Selection Board with held recommendations of both the candidates selected as Drivers for want of valid driving license; and
- 3. Whereas, the Jammu & Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/38/17/6050-52 dated 12.07.2017 released the recommendation in favour of both the selected candidates.
- 4. Now, therefore, in terms of J&K Special Recruitment Rules, 2015(SRO-202 dated 30-06-2015) and as recommended by the J&K

Services Selection Board, sanction is hereby accorded to the temporary appointment in favour of following two candidates as Driver(Divisional Cadre Kashmir) in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- in the J&K Excise & Commercial Taxes (Subordinate) Service with immediate effect:-

- 5. The appointment shall be subject to fulfillment of following conditions:-
  - A) The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015(SRO-202 dated 30-06-2015).
  - B) The appointee shall report to the Commissioner, Commercial Taxes within a period of 21 days from the date of issue of the order.
  - C) In case of failure of appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.
  - D) The appointees shall be allowed to join only on production of the following certificates in original:-
    - 1. Academic/Technical Qualification Certificates.
    - 2. Matriculation/Date of Birth Certificate.
    - 3. Health Certificate issued by Chief Medical Officer.
    - 4. Permanent Resident Certificate issued by the Competent Authority.
    - 5. Certificates from the District Industries Centre(DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
    - 6. Relevant Category certificates (in case of candidates belonging to reserved categories).
  - E) The appointment of the candidates as Driver(Divisional Cadre Kashmir) shall further be subject to the following conditions:
    - i. The appointees shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no

- right to claim their appointment as Driver and their appointment as such shall be deemed to have been cancelled ab-initio.
- If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled abinitio.
- The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
- The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
