Whereas, pursuant to the recommendations of the J&K Services Selection Board vide communication No.SSB/Sel./Secy/014/2300-06 dated 11-04-2014, No.SSB/Sel/Secy/014/3549-55 dated 13-05-2014 & No.SSB/Sel/Secy/014/2300-06 dated 11-04-2014, Shri Sheeraz Ahmad Tantray S/o Abdul Hamid Tantray R/o, Shopian, Mr. Yogesh Sharma S/o Yash Paul Sharma R/o Pallanwala Tehsil Akhnoor Distrct Jammu & Mr.Sachin Kumar S/o KC Bhagat R/o Sant Ashram Road Akhnoor, Jammu were appointed as Sub-Inspectors (Divisional Cadre Jammu/Kashmir) in the J&K Excise & Commercial Taxes (Subordinate) Service under RBA Category, OM/ALC category & SC category vide Government Order No.235-F of 2014 dated 17-10-2014, Government Order No.178-F of 2014 dated 24-07-2014 & Government Order No.175-F of 2014 dated 23-07-2014 respectively and put on probation for a period of two years;
