Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11.08.2015 referred 03 posts of Jr. Scale Stenographer (State Cadre) (OM=01, RBA =01 & SC=01) of the J&K Excise and Commercial Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

- Whereas, the Jammu & Kashmir Services Selection Board vide 02. communication No. SSB/Secy/Sel/2017/10471-77 dated 09.10.2017 forwarded a select list /recommendations of 01 candidate (OM=01) for the post of Jr. Scale Stenographer (State Cadre).
- Now, as recommended by the J&K Services Selection Board, 03. sanction is hereby accorded to the temporary appointment of Mr. Obaid Amin Dar S/o Mohammad Amin Dar R/o Solina South Srinagar under Open Merit Category (S.No. 01 in the select list) as Jr. Scale Stenographer (State Cadre) in the Pay Band of Rs. 9300-34800+ Grade Pay Rs. 4200/- in the J&K Excise and Commercial Taxes (Subordinate) Service with immediate effect.
- The appointment of the above said candidate shall be subject to 04. fulfillment of the following conditions:-

The appointee shall report to the Commercial Taxes Department A) within a period of 21 days from the date of issue of the order.

In case of failure of said appointee to join within the stipulated period, B) his appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointment including pay, service etc. shall be governed in terms of J&K Special Recruitment Rules, 2015 [SRO-202 dated 30-06-<u>2015</u>].

The appointee shall be allowed to join only on production of the following certificates in original:-

- 1. Academic/Technical Qualification Certificates.
- 2. Matriculation/Date of Birth Certificate.
- 3. Health Certificate issued by Chief Medical Officer.
- 4. Permanent Resident Certificate issued by the Competent Authority.
- 5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
- The appointment of the candidate as Ir. Scale Stenographer shall E) further be subject to the following conditions:-
 - The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his appointment as Jr. Scale Stenographer and his appointment as such shall be deemed to have been cancelled ab-initio.
 - If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled abinitio.
 - iii. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (i) and (ii) above are received in his favour.
 - The appointee shall be on probation for a period of 05 years.
 - The inter-se-seniority of the appointee shall be strictly as per his merit in the select list.
 - vi. The appointment of the said candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-05-2009.
