Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11-08-2015, among other category posts, had referred 23 posts of Junior Scale Stenographer (Divisional Cadre Jammu) of the J&K Excise & Commercial Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

- **2-** Whereas, the J&K Services Selection Board vide communication No.SSB/Secy/Sel/2017/1106-13 dated 24-01-2017 has forwarded the selection list of the 13 candidates for the post of Junior Scale Stenographer (Divisional Cadre Jammu) advertised vide Advertisement Notice No. 05 of 2015 dated 01-09-2015; and
- **3-** Whereas, the Board, has also intimated that out of total 23 advertised posts(Divisional Cadre Jammu), 10 category posts (RBA=05, SC=02, ST=02, ALC=01) have been kept un-filled due to non-availability of eligible candidates; and
- 4- Whereas, the select list of inter-alia includes Mr. Ajay Sharma S/o Inder Dev Sharma R/o Rajpura Mangotrian, Jammu (S.No. 11 under OM category) in whose case the Board has withheld its recommendations; and
- 5- Whereas, in the above backdrop, the department has to consider formal appointment in favour of only 12 selected candidates (Divisional Cadre Jammu) excluding (S.No. 11 under OM category) of the select list whose recommendations have been withheld by the Board; and

- 6- Now, therefore, as recommended by the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment in favour of 12 selected candidates (Divisional Cadre Jammu) indicated in "Annexure-A" to the order as Junior Scale Stenographer (Divisional Cadre Jammu) in the Pay Band of Rs. 9300-34800 with Grade Pay of Rs. 4200/- in the J&K Excise and Commercial Taxes (Subordinate) Service with immediate effect subject to fulfillment of following conditions:-
  - A) The appointee(s) shall report to the respective departments as indicated against each in "Annexure-A" to this order within a period of 21 days from the date of issue of the order.
  - B) In case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled without any further notice.
  - C) The appointee(s) shall be allowed to join only on production of the following certificates in original:-
    - 1. Academic/Technical Qualification Certificates.
    - 2. Matriculation/Date of Birth Certificate.
    - 3. Health Certificate issued by Chief Medical Officer.
    - 4. Permanent Resident Certificate issued by the Competent Authority.
    - 5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
  - D) The appointment of the candidates as Junior Scale Stenographer shall further be subject to the following conditions:-
    - Each appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his/her appointment as Junior Scale Stenographer and his/her appointment as such shall be deemed to have been cancelled ab-initio.
    - ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.
    - iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
    - iv. The appointment of the said candidates is as per SRO 202 of 2015 dated 30-06-2015.
    - v. The appointee(s) shall be on probation for a period of 05 years.
    - vi. The inter-se-seniority of the appointee(s) shall be strictly as per their merit in the select list.
