Addendum to Government Order No. 39-FD of 2018 Dated 05.02.2018

In the Government Order No. 39 dated 05.02.2018 regarding grant of amnesty for settlement of unresolved issues in the old Tax regime for smooth implementation of Goods and Service Tax the following explanation shall be added after Para 1 and Para 2(i) of Annexure-B (Part-I).

"In respect of dealers dealing in Foreign Liquor including IMFL, bear, ale porter and other fermented drinks, the scheme shall include period from 1st April, 2017 to 31st August, 2017".

Further, in Declaration-I & Declaration-II of Annexure-B and Annexure-C the words "Jammu and Kashmir Value Added Tax, 2005 (now repealed)" wherever occurred shall be replaced with "Jammu and Kashmir General Sales Tax Act, 1962".
