- II) The Committees shall also ensure that the non- network hospitals/ labs/ nursing homes at least minimally conform to the standards/ criteria laid down/ accepted for such like hospitals/ labs in the State under the relevant regulatory regime.
- III) The Committees may, if necessary, co-opt any other technical member/expert in their deliberations.

The Committees shall finalise the whole process within one month positively.
