Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11.08.2015 referred 74 posts (OM=21, RBA=25, SC=10, ST=12, OSC=02 & ALC=04) of Sub-Inspector (Divisional Cadre Jammu) of the J&K Excise and State Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

2. Whereas, the Jammu & Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/2019/155-61 dated 08-01-2019 forwarded a select list of 74 candidates for the post of Sub-Inspector (Divisional Cadre Jammu) advertised vide item No. 254 (05 of 2015) indicating therein that recommendation in favour of 18 Sub-Inspector have been withheld for want of requisite documents; and

3. Whereas, the Finance Department vide Government Order No. 65-FD of 2019 dated 29.01.2019 issued appointment orders in favour of 56 Sub-inspectors; and

4. Whereas, J&K Services Selection Board vide No.SSB/Secy/Sel/13/19/J/1416-18 dated 05.03.2019, released the recommendations in form of 15 selectees; and

5. Whereas, one of the candidate, Mr. Mandil Vaid S/o Sh. Pardeep Vaid R/o Mahanpur Basoli, Kathua has furnished an affidavit duly attested by Judicial 1st Class Magistrate expressing his unwillingness to join in the Finance Department as Sub-Inspector; and

6. Now, as recommended by the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of the following 14 candidates as Sub-Inspector (Divisional Cadre Jammu) in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 2400/- (pre-revised) in the J&K Excise

and State Taxes (Subordinate) Service with immediate effect and shall report to the Head of Department as indicated against each within a period of 21 days from the date of issuance of this order:-

7. The appointment of the above said candidate shall be subject to fulfillment of the following conditions:-

A) The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015 [SRO-202 dated 30-06-2015].

B) The appointee shall be allowed to join only on production of the following certificates in original:-

1. Academic/Technical Qualification Certificates.
2. Matriculation/Date of Birth Certificate.
3. Health Certificate issued by Chief Medical Officer.
4. Permanent Resident Certificate issued by the Competent Authority.
5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
6. Reserved Category Certificate (in case of candidates belonging to reserved category).

C) The appointment of the candidate as Sub-Inspector shall further be subject to the following conditions:-

- i. The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his appointment as Sub Inspector and his appointment as such shall be deemed to have been cancelled ab-initio.
- ii. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- iii. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (i) and (ii) above are received in his favour.
- iv. The appointee shall be on probation for a period of 05 years and shall undergo and qualify the Departmental Examination (Excise and Taxation Part-1 Examination) within the period of probation.
- v. The inter-se-seniority of the appointee shall be strictly as per his merit in the select list.
