## Government Order No.388-F of 2019 Dated 10 - 07 - 2019

In continuation to Government Order No. 408-F of 2018 dated 24-09-2018, it is hereby ordered that State Government employees continuing to draw their pay as per 6<sup>th</sup> CPC, shall be paid Dearness Allowance as under:-

Existing Rate of DA	Revised Rate of DA	W.e.f.
148% of Basic Pay	154% of Basic Pay	01.01.2019 -

- a. The arrears on account of additional instalment of DA from January, 2019 to June, 2019 shall be paid in cash in July, 2019 and shall form part of the monthly salary from July, 2019 onwards.
- b. The payment of Dearness Allowance involving a fraction of 50 paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
