- 4. The appointment of the above said candidates shall be subject to fulfillment of the following conditions:-
 - A) The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015 [SRO-202 dated 30-06-2015].
 - B) In case of failure of said appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
 - C) The appointees shall be allowed to join only on production of the following certificates in original:-
 - 1. Academic/Technical Qualification Certificates.
 - 2. Matriculation/Date of Birth Certificate.
 - 3. Health Certificate issued by Chief Medical Officer.
 - 4. Permanent Resident Certificate issued by the Competent Authority.
 - 5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
 - 6. Reserved Category Certificate (in case of candidates belonging to reserved category).
 - D) The appointment of the candidates as Sub-Inspector shall further be subject to the following conditions:
 - i. The appointees shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his/her appointment as Sub



- Inspector and his/her appointment as such shall be deemed to have been cancelled ab-initio.
- ii. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- iii. The salary of the appointee shall not be drawn and disbursed to him/her unless the satisfactory reports in respect of (i) and (ii) above are received in his/her favour.
- iv. The appointee shall be on probation for a period of 05 years and shall undergo and qualify the Departmental Examination (Excise and Taxation Part-1 Examination) within the period of probation.
- v. The inter-se-seniority of the appointee shall be strictly as per his/her merit in the select list.
- E) All the appointees shall undergo one month training at Excise & Taxation Institute, Nagrota, Jammu.
