Subject:- Payment of Dearness Allowance to Government pensioners/family pensioners continuing to draw their pension/family pension as per 6th CPC- revised rates effective from 01.01.2019 & 01.07.2019.

**Government Order No. 497-F of 2019
Dated 27 -12 - 2019**

In continuation to Government Order No. 409-F of 2018 dated 24-09-2018, it is hereby ordered that Government pensioners/family pensioners continuing to draw their pension/family pension as per 6th CPC, shall be paid Dearness Allowance as under:-

Existing Rate of DA	Revised Rate of DA per month	W.e.f.
148% of basic pension/ family pension	154% of basic pension/family pension	01.01.2019
	164% of basic pension/family pension	01.07.2019

- i) The arrears on account of additional instalment of DA from January, 2019 to November, 2019 shall be paid in cash in December, 2019 and shall form part of the monthly pension/family pension from December, 2019 onwards.
- ii) The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.


