In this regarg, the concerned HOD has informed that Shri Anurag Sharma, Sub-Inspector was appointed vide Govt. order No. 42-F of 2015 dated 17- 3-2015 with the directions that inter-se-seniority of the appointee shall be strictly in accordance with the merit secured by the candidate as per the select list furnished by the J&KSSB vide letter No. SSB/Sel/Secy/014/3549-55 dated 13-5-2014. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order failing which the above Seniority list shall be deemed to have attained finality.
