**Government Order No: 249 -F of 2021
Dated: 16 -09-2021**

In continuation to Government Order No. 495-F of 2019 dated 27-12-2019, it is hereby ordered that Government employees continuing to draw their pay in the pre-revised Scales/Grade pay as per 5th CPC, shall be, paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
312% of Basic Pay	356% of Basic Pay	01.07.2021

- (i) The increase subsumes the additional installments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Allowance for the period from 01.01.2020 till 30.06.2021 shall remain at 312%.
- (ii) The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
