In continuation to Government Order No 251-F of 2021 dated 16.09.2021, it is hereby ordered that Government Pensioners/Family pensioners continuing to draw their Pension/ Family pension as per 6<sup>th</sup> CPC, shall be, paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
189% of Basic Pension/Family Pension	196% of Basic Pension/Family Pension	01.07.2021

- (i) The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
- (ii) The arrears on account of additional installment of DA from July, 2021 to November, 2021 shall be paid in cash in December, 2021 and shall form part of the monthly pension/Family Pension from December, 2021 onwards.
