b. There have been/are some Accounts Personnel who had been granted In-situ promotions corresponding to the pre-upgraded pay scales between 1-1-1996 to the date of issue of notification SRO-94 dated 23-03-2007.

Doubts have been expressed as to what In-situ pay scales shall be allowed to them after upgradation of the functional pay scale w.e.f. 1-1-1996.

c. The In-situ pay scales have c. been embodied in the unrevised table contained in J&K Civil Service (HSPS) Rules, 1996, as amended from time to time.

Doubts have been expressed as to how the Insitu Pay scales be computed after upgradations of the functional pay scales in terms of the provisions of SRO-94 dated 23-03-2007

- b. Since the functional pay scales have been upgraded retrospectively w.e.f 1-1-1996, the In-situ pay scales granted by the competent authorities between 1-1-1996 to the date of issue of notification of SRO-94 dated 23-03-2007 shall be deemed to have been granted in the In-situ pay scales corresponding to the upgraded functional pay scales of the posts without any further/fresh sanction of the competent authorities.
- scales shall be granted in the revised pay scales contained in the J&K Civil Service (Revised Pay) Rules, 1998 as recast vide SRO-350 dated 22-12-1998 corresponding to the scales as contained in J&K Civil Service (HSPS) Rules, 1996 read with the upgraded pay scales vide SRO-94 dated 23-03-2007.

Kindly refer to your communication resting under letter No. TM/ PFP-II/2005-06/Edu-Policy/891-96 dated 30-05-2006 on the subject captioned above. The matter has been examined in Finance Department and in view of the fact that Finance Department has all along held that upgradation of a post cannot be construed as promotion, the clarifications to the doubts raised are as under:

- (i) Any teacher with more than 9 years stagnation service with his entry qualification as Graduate or above and who had been granted 1st Higher Standard Pay Scale of Rs. 4500-125-7000 shall be placed in the In-situ pay scale of Rs. 5000-8000 w.e.f. 01-04-2005.
- (ii) Any teacher with more than 18 years stagnation service with entry qualification as Graduate or above and who had been granted 2nd Higher Standard Pay Scale of Rs. 5000-8000 after fulfillment of all terms and conditions shall be placed in the upgraded Pay Scale of Rs. 5150-8300 w.e.f. 01-04-2005.
- (iii) Any teacher with more than 27 years stagnation service with entry qualification of Graduation or above and who had been granted 3rd Higher Standard Pay Scale of Rs. 5150-150-8300 corresponding to the pre-upgraded pay scale of Rs. 4000-6000 after fulfillment of all terms

and conditions shall be placed in upgraded pay scale of Rs. 5500-175-9000 w.e.f. 01-04-2005.

Once the pay of the teacher (with qualification of graduation and above at entry level) is fixed in the above manner, it is requested to spell out if there are any further doubt/doubts in respect of Masters w.e.f. 01-04-2005 as the post of Masters carrying the upgraded pay scale of Rs. 6500-200-10500 has got the same In-situ pay scale of Rs. 6700-10700 corresponding to the pre-upgraded pay scale of Rs. 5700-125-10100.

Empowered Committee constituted vide Govt. Order No. 26-F of 1994 dated 31-01-1994 have so far created 54989 number of temporary posts of Helpers for regularization of 58942 number of DRWs engaged prior to 31-01-1994. A post of Helper is of temporary nature and ceases to exist as and when the incumbent regularized against the post of a Helper is adjusted against any hierarchical post.

The Government had wound up the Empowered Committee vide Govt. Order No. 224-F of 2006 dated 12-7-2006 and the Finance Department is considering each case of pending DRWs engaged prior to 31-01-1994 on its merits, and accordingly conveys decision to the Department.

Finance Department has come to know that various Departments are utilising the temporary posts of Helpers for compassionate appointment under SRO-43/regularization of DRWs at their own level, which is against the spirit of rules and decisions conveyed time and again to each sectoral head/s to the effect that the post of a Helper is of a temporary nature and ceases to exist as and when the incumbent working against this post is adjusted against any available hierarchical post/dies/resigns.

As such it is enjoined upon all the Administrative Secretaries/ HODs to provide the information relating to Helper posts created so far in the Department for regularization of DRWs and their adjustment against the available hierarchical posts under their administrative control within a month to the Finance Department as per the format enclosed.
