Government Order No. 24 -F of 2014 Dated 05 - 02 - 2014

In continuation to Government Order No. 126-F of 2013, dated 15.05.2013, it is hereby ordered that the State Government employees including Work Charged and Whole Time Contingent Paid employees, working in regular pay bands /scale, shall be paid Dearness Allowance as under:-

Existing Rate of DA	Revised Rate of DA	Date from which applicable
80 %	90 %	01.07.2013

- The differential amount on account of enhancement in DA by 10% w.e.f. July, 2013 to February, 2014 shall be paid through the GPF route with lock-in-period of one year and form part of the monthly salary there onwards.
- (ii) The differential amount on account of DA to the State Government employees governed by the New Pension Scheme (NPS) shall be paid in cash w.e.f July, 2013 to January, 2014 in the month of February, 2014. The employees' share @ 10% shall be deducted at source and credited to the respective PRAN Numbers alongwith the matching share by the employer. Thereafter, the enhancement in the DA by 10% shall form part of their monthly salary
- (iii) The basic pay for the purpose of this order shall mean the basic pay as defined in Note below Article 27(aa) of the J&K Civil Service Regulations.
- (iv) The payment of Dearness Allowance involving a fraction of 50 paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
- (v) The provisions of this order shall also apply, mutatis-mutandis to the All India Service Officers, serving in connection with affairs of the State.
